**(A) ELIGIBILITY CRITERIA FOR SPECIALIZED FIRMS/ BIDDERS:**

- a) Average Annual Financial turnover during the last 3 years, ending 31<sup>st</sup> March 2023, should be at least 50% of the estimated cost.
- b) Should have satisfactorily completed the works as mentioned below with some Central/State Government department / Central/State Autonomous Body / PSU during last seven years ending previous day of last date of submission of bids:

Three similar works each of value not less than 40% of the estimated cost put to tender with capacity of individual Grid Connected Solar PV system being 80% of individual capacity (in case of more than one system, higher capacity shall be taken) of the Grid Connected Solar PV system .

OR

Two similar works each of value not less than 60% of the estimated cost put to tender with capacity of individual Grid Connected Solar PV System being 80% of individual capacity (in case of more than one system, higher capacity shall be taken) of the Grid Connected Solar PV system .

OR

One similar work each of value not less the 80% of the estimated cost put to tender with capacity of individual Grid Connected Solar PV System being 80% of individual capacity (in case of more than one system, higher capacity shall be taken) of the Grid Connected Solar PV system.

- c) The bidder should be a legal entity registered in India with valid PAN and GST registration.
- d) The agency should have Solvency of amount equal to 40% of the estimated cost put to the tender.
- e) The agency should not have incurred any loss (profit after tax should be positive) in more than two consecutive years during the last five years ending 31st March 2023 duly audited and certified by the CA, scanned copy of certificate from CA to be uploaded.

Note:

1. Similar works means "SITC of grid connected roof top Solar PV system/power plant"
2. The value of all above executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to previous day of last date of submission of tenders.
3. Certificate of successful completion of work in respect of the experience issued by an officer not below the rank of Executive Engineer or equivalent and shall clearly mentioning the Name of work, amount of work done , date of start & date of completion (stipulated and actual) and clearly mentioning the levy of compensation imposed if any.
4. **The Works should have been executed in the same name** in which present bid is made. Joint ventures are not accepted.
